POST: ICT/COMPUTING TEACHER

JOB PURPOSE:

- To devise, implement and deliver an appropriately broad, balanced, relevant and differentiated ICT/Computing curriculum for all learners.
- To ensure that the school ICT curriculum gives the opportunity to explore a varied mix of technologies and computing skills that inspire further exploration of the subject.
- To facilitate and encourage learning experiences which provide learners with the opportunity to achieve their potential and contribute to raising standards.
- To uphold the ethos, aims and values of the school, its policies and codes of practice at all times and in all circumstances.
- To promote ICT and Computing excellence throughout the school.
- Managing and organisation of school ICT equipment.
- Responsibility for social media input and policy with SMT.
- Responsibility for school website management and policy with SMT.

KEY RESPONSIBILITIES:

- Set high expectations which inspire, motivate and challenge pupils
 - Establish a safe and stimulating environment for pupils, rooted in mutual respect
 - Set goals that stretch and challenge pupils of all backgrounds, abilities and dispositions
 - Demonstrate consistently the positive attitudes, values and behaviour which are expected of pupils

• Promote good progress and outcomes by pupils

- Be accountable for pupils' attainment, progress and outcomes
- Be aware of pupils' capabilities and their prior knowledge, and plan teaching to build on these
- Guide pupils to reflect on the progress they have made and their emerging needs
- Demonstrate knowledge and understanding of how pupils learn and how this impacts on teaching
- Encourage pupils to take a responsible and conscientious attitude to their own work and study

	and know how to adapt teaching to support pupils' education at different stages of

	• Have a clear understanding of the needs of all pupils, including those with SEN; those of
	high ability; those with EAL; those with disabilities; and be able to use and evaluate
	distinctive teaching approaches to engage and support them.
•	Make accurate and productive use of assessment
	Know and understand how to assess the relevant subject and curriculum areas, including
	statutory assessment requirements
	Make use of formative and summative assessment to secure pupils' progress
	use relevant data to monitor progress, set targets, and plan subsequent lessons
	• Give pupils regular feedback, both orally and through accurate marking, and encourage
	pupils to respond to the feedback
•	Manage behaviour effectively to ensure a good and safe learning environment
	• Have clear rules and routines for behaviour in classrooms, and take responsibility for
	promoting good and courteous behaviour both in classrooms and around the school, in
	accordance with the school's behaviour policy
	• Have high expectations of behaviour, and establish a framework for discipline with a
	range of strategies, using praise, sanctions and rewards consistently and fairly
	• Manage classes effectively, using approaches which are appropriate to pupils' needs in
	order to involve and motivate them
	• Maintain good relationships with pupils, exercise appropriate authority, and act decisively
	when necessary
•	Subject Specific Roles
	To monitor ICT equipment in school with support from IT Technician.
	• To liaise with SMT to monitor the school online communications (Social/Google/Website).
	• To act as a role model in ICT skills to other staff.
	• To assist in promoting the school to new parents e.g. photograghy, editing and graphics.
•	Fulfil wider professional duties
	Make a positive contribution to the wider life and ethos of the school

- Develop effective professional relationships with colleagues, knowing how and when to draw on advice and specialist support
- Deploy support staff effectively
- Take responsibility for improving teaching through professional development, responding to advice & feedback from colleagues
- Communicate effectively with parents with regard to pupils' achievements and well-being
- Take on an additional responsibility as designated by the school
- To take on an after school club responsibility for a class each week.

PERSONAL & PROFESSIONAL CONDUCT

Uphold public trust in the profession and maintain high standards of ethics and behaviour, within & outside school

- a) Treating pupils with dignity, building relationships rooted in mutual respect, and at all times observing proper boundaries appropriate to a teacher's professional position
- b) Having regard for the need to safeguard pupils' well-being, in accordance with statutory provisions
- c) Showing tolerance of and respect for the rights of others
- d) Not undermining fundamental British values, including democracy, the rule of law, individual liberty and mutual respect, and tolerance of those with different faiths and beliefs
